**AN ORDINANCE AMENDING WATER AND SEWER USAGE
IN THE TOWN OF SMITHSBURG**

The Mayor and Council, as the duly constituted legislative body, after having held a public hearing, have determined that it is in the best interests of the Town of Smithsburg and the citizenry in general to revise certain water and/or sewage usage fees as set forth herein.

NOW, THEREFORE, BE IT RESOLVED, ENACTED and ORDAINED that *Chapter 390, ARTICLE VIII. WATER AND SEWER RATES AND HOOKUP FEES §390-21. WATER AND SEWER RATES* be and is hereby revoked; and be it further

ADDITIONAL WATER RATE PER THOUSAND GALLONS - \$7.67

ADDITIONAL SEWER RATE PER THOUSAND GALLONS - \$8.23

OUT OF TOWN CUSTOMERS

WATER & SEWER RATE:

MINIMUM QUARTERLY BILL BASED ON 6,000 GALLONS

WATER \$95.26

SEWER \$128.14

\$223.40 + 15.00 Bay Fund = \$238.40

ADDITIONAL WATER RATE PER THOUSAND GALLONS - \$11.51

ADDITIONAL SEWER RATE PER THOUSAND GALLONS - \$12.35

OUT OF TOWN SEWER ONLY CUSTOMERS


\$200.00 per quarter plus \$15.00 Bay Fund


BE IT FURTHER RESOLVED, ENACTED and ORDAINED that all surpluses generated as a result of these newly enacted and increased rates shall be utilized for water and/or sewer infrastructure unless otherwise specified or directed by the Council by Resolution; and

BE IT FURTHER RESOLVED, ENACTED and ORDAINED that this Ordinance is being Introduced and Passed as an Emergency Ordinance in accordance with the *Charter of the Town of Smithsburg* and the rates specified herein shall be considered effective commencing on July 1, 2023.

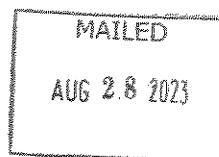

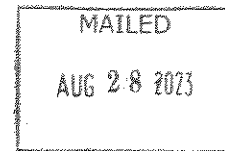
